Second Site is the best way to publish your TMG data in HTML format. It has more features and provides more control than any GEDCOM-based method. If you are serious about publishing your TMG data on the Web, or if you are sharing your data with family members on custom CDs, you need Second Site!

Second Site is also a great tool to review your dataset. It is fast, and the HTML format makes the data easy to browse. Many users have reported that it has helped them to find inconsistencies in their data and other problems.

Are you afraid that you don't have what it takes to get a site published? Combine Second Site with Family History Hosting (FHH), a web hosting service designed for genealogists. Second Site includes a special one-step publish feature for use by FHH customers. As part of the FHH service, I'll help you register a domain, fine-tune your site, and publish the first version of your site. Second Site and FHH can help you get from offline to online!

#### What It Does

Second Site creates web pages from a genealogy database. It generates either narrative or grid style person pages, a master index, a surname index, and source pages. Check out the partial list of features.

#### Second Site Version 3.4 Released

This release includes two new indented charts, Descendant (Indented) and Pedigree (Indented). Based on the feedback from beta testers and users who commented on early previews, the new charts will be popular. The charts can be expanded or collapsed to show a subset of the tree and that allows the user to focus on the people of interest. You can see an example descendant chart of and an example pedigree chart of on the Second Site Demonstration of site.

Second Site 3 now supports Web Fonts to expand font-family choices beyond the short-list of fonts that are supported by browsers. This facility must be used with care—Web Fonts have to be downloaded with the pages that used them, and thus they can make pages load slowly—but there are some great ways to use Web Fonts, such as to brand your site by using a distinctive font for the Site Title. The Second Site demonstration site uses the font "Lobster" for that purpose.

This release also includes other minor enhancements. For a description of the other changes, please see the **Change Log**.

#### Download and Install

All existing **Second Site 3** customers should download this *free* upgrade via the **Downloads** page. When you install the latest version, you will not lose any SDF files or sites you made with any previous version of Second Site 3.

I strongly recommend that you **uninstall** any previous version of Second Site 3 before you install this version. Previous versions of Second Site 3 include files that are no longer needed; if you install this version into a folder that already contains a previous version, those files will not be removed.

If you install this version of Second Site 3 on a PC that had a previous version of Second Site 3 installed, you will not need your registration information.



#### **Enhancements**

- Added the Indented Descendant Chart and Indented Pedigree Chart
- Added support for Web Fonts which expands the set of font families you may use on your web pages
- Reimplemented the Descendant Chart; this corrects some long-standing limitations like missing spouses in the last generation of the chart and counter-intuitive box placement when optimizing the chart; the Optimize Space property now supports three levels of optimization
- Added the Include Marriage Date property to the Descendant and Indented Descendant charts
- Added the Generation Number property to all Descendant and Pedigree charts
- Changed the Person Entry Chart List to include all instances where a person appears in the chart
- Changed the Description property in the User Style sections to an editable field so that users may use the field for notes that describe their custom User Styles
- Added the Repeat Header Rows property to the Edit DNA Group window of the DNA Grid User Item
- Added Header and Footer to the list of content items in the Page Content section of various User Items including the Custom Page User Item; like other items in the list such as Extra Sidebar, these properties allow users to add content to a section of the page for the current page only
- Modified the menubar and sidebar; the item for the current page, if any, will be rendered in the highlighted (hover) state

#### Changes


- Added the "Use font for Main Page title" checkbox property to the Stylesheets. System. Site Title section; when checked, SS will use the font-family, font-style, and font-weight parameters from the Site Title section for the Page Title on the Main Page; this simplifies the use of a special font-family for the Site Title
- Changed the method Second Site uses to reduce the number of files in the output folder when creating a site that will be published via CD or DVD: Second Site now generates the files directly into the "site" subfolder rather than moving them there after making the site
- Changed the default labels for descendant chart legends from "Female" and "Male" to "Daughter" and "Son"
- Changed the default labels for pedigree chart legends from "Female" and "Male" to "Mother" and "Father"
- Added the User Item Strings.DNA Kit Name Header property to enable setting the column header for the kit number/name column in a DNA Grid
- Changed the sort sequence for Map Item Lists; the default sort sequence for a set of places from a single Map Events entry is now alphabetic unless the Map Events entry uses a connecting line, in which case the items are sorted by the date of the earliest event at the location
- In the surname index, changed regular spaces in surnames to non-breaking spaces
- Changed the Three Columns Format to avoid an issue in Firefox where a cell border was not rendered properly

#### **Fixes**

 Fixed a bug where the Create GENDEX File feature did not filter the GENDEX.txt file contents propertly

Three Column	The Three Column Format shows the information for a person in three columns. Column one on the left has a label, which is the tag name or a section name. The middle column has the date. (The middle column is omitted for some entries.) The right-hand column has the other information for a tag, which can either be in sentence format (Detail Format=Use Sentence) or a list that includes the place and a list of people involved in the event (Detail Format=Raw Data).
	You can modify the borders, background colors, etc., for some interesting effects. The left-hand column is formatted via the "Grid Colum 1" style, the middle column by "Grid Column 2" style, and the right-hand column by "Grid Column 3".  (example )






# User Items screen showing charts - click on "Add" to input new charts



#### Descendant chart Indented screen




## Edit Descendant chart Indented screen




